PRIVACY POLICY

This Privacy Policy document contains types of information that is collected and recorded by xfb Analytics (data controller) and how we use it in compliance with the provisions of Regulation (EU) 2016/679 (General Data Protection Regulation).

This Privacy Policy applies only to our online activities and is valid for visitors to our website with regards to the information that they shared and/or collect on our website. This policy is not applicable to any information collected offline or via channels other than this website.

By using our website, you hereby consent to our Privacy Policy and agree to its terms.

Information we collect

The personal information that you are asked to provide, and the reasons why you are asked to provide it, will be made clear to you at the point we ask you to provide your personal information. The legal basis of collecting and using personal data is the consent of data subjects and the legitimate interest of the Organizer of Hackathon. Data subjects are the applicants (who fills and submit registration form on Football Analytics Hackathon 2025 website).

If you contact us directly, we may receive additional information about you such as your name, email address, phone number, the contents of the message and/or attachments you may send us, and any other information you may choose to provide.

When you register for the Football Analytics Hackathon 2025, we ask for your contact information, including items such as name, email address, telephone number, date of birth, your company name, country, state, zip code, city, address, your coding/programming skills, football analytics experience, previous hackathon experience and optionally your gender.

Information provided to Data Processors

During your application process, you will be required to pay the entry fee, which is a precondition of participation and due to the payment, we will ask your data (full name, phone number, country, state, zip code, city, address) which will be handed over to payment service provider OTP Mobil

Ltd. as referred in Terms and Conditions of Hackathons 2025) for payment purposes. For the issuance of your entry fee invoice, we use an online program 'Billingo'. Your private data (full name, country, state, zip code, city, address) will be transferred to Billingo Technologies Pte Ltd. for billing purposes. How we use your information

We use the information we collect in various ways, including to:

- organize and arrange Hackathon 2025 as a competition;
- notify participants of Hackathon 2025;
- publish the name and title/experience of winners of Hackathon 2025;
- provide, operate, and maintain our website;
- improve, personalize, and expand our website;
- understand and analyse how you use our website;
- develop new products, services, features, and functionality;
- communicate with you, either directly or through one of our partners, including for customer service, to provide you with updates and other information relating to the website, and for our own marketing and promotional purposes;
- send you e-mails;
- find and prevent fraud.

Data recipients

Personal data will be communicated to recipients, who will process the data as processors (art. 28 of EU Reg. 2016/679) and / or as natural persons acting under the authority of the data controller and data processor (art. 29 of EU Reg. 2016/679), for the purposes listed above and to third parties.

Data can be communicated to:

- service providers specifically identified and authorised by xfb Analytics (such as payment service provider OTP Mobil Ltd) or other subjects with whom xfb Analytics executed co-operation agreements with regard to the platform or the services covered by the platform;
- subjects providing management services for the computer system and communication networks (including email);
- firms or companies within the context of assistance and consultancy relationships;

- competent authorities to fulfil legal obligations and/or provisions of public bodies, upon request;
- in case the processing is done for administrative or accounting purposes, data can be transferred to business information companies for the assessment of the solvency and payment patterns and/or to debt collection agencies.

How do we protect the security of your personal data?

We are committed to ensuring the security of your personal data by implementing technical and organisational measures that meet industry standards.

We keep your personal data on secure servers using state-of-the-art encryption algorithms and storage expansion mechanisms.

Please note that, despite our best efforts to protect your personal data, the security of information transmitted over the World Wide Web in general and other public networks can never be guaranteed and such data may be intercepted and used by unauthorised third parties. We are not responsible for the vulnerability or susceptibility of systems outside our control. Please note that xfb Analytics are not under the scope of 2022/2555 EU Directive (NIS2 Directive).

How long do we keep your personal data?

As a general rule, your personal data will be stored for as long as Football Analytics Hackathon 2025 lasts and/or you have an account. However, you may request us to delete certain data or to terminate your account at any time, and we will respond to your request without exception, while ensuring that certain data remain in compliance with legal retention requirements, even after termination of your account.

Log Files

xfb Analytics follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analysing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

Cookies and Web Beacons

Like any other website, our website uses 'cookies'. These cookies are used to store information including visitors' preferences, and the pages on the website that the visitor accessed or visited. The information is used to optimize the users' experience by customizing our web page content based on visitors' browser type and/or other information.

Managing cookies for analytics

Data Protection Rights

We would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:
